About Bhagini Samaj

Bhagini Samaj, was established in 1937. Its mission is to provide care, protection, education and support to poor needy children in Mangalore. Since its inception, Bhagini Samaj has been providing support to destitute, orphans and abandoned children.



Gross Enrollment Ratio (GER) at the Secondary Level in government schools in India is below 50%

(District Information System for Education - DISE, 2011-12)

Bhagini Samaj sponsored 10 girls for higher education through iPartner India's support. The selection was made amongst girls belonging to extremely poor families, having secured 80 percent and above in their 10th standard and having serious financial constraints to pursue higher education. Without the support of iPartner India, many of these girls would have dropped out of schools. **Bhagini Samaj believes that education is crucial for the empowerment of girls and women** and the realisation of all other human rights. **Educating a girl has a transformational effect that changes communities and societies.**



Savitha, 17 years old, secured 83.2 percent in 10th standard. Her father is an auto rickshaw driver and her mother is a beedi factory worker.

"I am very happy that I got selected for this scholarship. My dream to attend college has finally been fulfilled. I would like to work in a reputed company someday and take care of my family.

Bhagyalaxmi, 18 years old, secured 88.9 percent in 10th standard. Her father left her family when she was 5 years old. Her mother works as a *coolie* (labourer). *"Growing up with a single parent was very difficult for me and my younger siblings. I have seen my mother's struggle to feed and educate us. Now that I have this opportunity, I want to study hard and find a good job. One day I want to buy a house for my mother."*



About Milaap

Milaap, which means 'connecting people' in Hindi & Urdu was initiated in June 2010, by three passionate young entrepreneurs who had one single vision, to change people's concept of giving and make it a personal, transparent and sustainable process. The end borrowers are the deserving, working poor of India, students, small businesses, families who need a small amount of capital to get ahead and change their lives



Milaap launched five rural entrepreneurs to set up five Reverse Osmosis (RO) water plants set for five communities in Hubli, Dharvad, Gadag, Haveri and Belgaum districts of Northern Karnataka. With iPartner India's support, Milaap successfully implemented the programme which now provides potable water within the community.

Milaap partners with proven, credible grass-root level organiszations ('Field Partners') to identify deserving borrowers, amount of financial assistance they need and its purpose.

In rural areas, many women derive their livelihoods from small-scale farming, almost always informal and often unpaid (Fontana & Paciello, 2010)



"It has been my dream to start a small business set up of my own. I never thought that this dream will ever be fulfilled until iPartner India and Milaap helped me set up RO water plant in our village. I am not only a proud business owner but happy that our village now has access to clean drinking water" Fakeerapa, rural entrepreneur "Water is something that takes away life and something that gives life too. Since public water supply is never enough, as a woman I understand how hard it is to keep my family healthy. With the support of iPartner India and Milaap, my community people now receive daily drinking water at a very small cost. This frees them to give more time towards earning their livelihoods."

Children

With over 40 per cent of India's population below the age of 18, India is the "youngest" country in the world. iPartner India recognises the need to support this issue, and through its donors supports several worthwhile projects

Education

India has lower literacy rates than most countries in sub-Saharan Africa. Around 400 million Indians - almost 40 per cent of the population - cannot read and write and nearly 40 million children (aged 6 to 14 years) are out of school. iPartner India believes higher levels of education is the key to a thriving society and does this by providing disadvantaged children with quality education.

Health

The majority of Indian people live in poverty and as such are at risk from many preventable yet debilitating diseases and fatal infections. Poor public health services exacerbate the situation.

Livelihoods

India is home to a third of the world's poorest people. Around 85 per cent of the population lives on less than \$2.50 a day. Although the Indian economy has grown over the last two decades, its growth has been uneven within different social groups.

Climate Change

This burdens a socio-economic system which is already facing tremendous pressure due to India's urbanisation, industrialisation and economic growth. India's most abundant energy resource is coal, which although driving its economic growth is also making it more vulnerable to the impact of climate change.


Studies have shown that weather-related disasters affect women more than men, both in terms of number of deaths and post-recovery wellbeing. (UNDP)
